



Budget 2024 – Capital Plan


Budget 2024 - Capital Plan Envelopes

(millions of dollars)






Budget 2024 – TEC Budget Breakdown

Economic Corridors

- We see key economic corridors as critical parts of bringing goods to market and supporting economic growth by providing safe and efficient highway connections.
- In 2024/25 Alberta Transportation and Economic Corridors made significant capital investments in Economic Corridors.
 - Over \$83 million is invested on 26 Roads and Bridges engineering projects to grow economic corridors.
 - Over \$1.35B million is invested on 173 Capital Maintenance and Renewal projects to enhance existing economic corridors.




Passenger Rail
